ORDER ADOPTING JUDICIAL CALENDAR FOR 2027

BY ORDER of the Superior Courts of the Chattahoochee Judicial Circuit, the attached calendar constitutes the official schedule for the year 2027 and takes PRIORITY over any matters not scheduled thereupon, subject to the Uniform Superior Court Rules and applicable Georgia law.

Cases in the Superior Courts of Chattahoochee, Harris, Marion, Talbot, and Taylor Counties shall not be assigned exclusively to a specific Judge unless otherwise ordered by the Court.

Civil, domestic relations, and all other non-criminal cases filed in the Superior Court of Muscogee County shall be randomly assigned by the Clerk of said Court as provided in Georgia Uniform Superior Court Rules 3.1 and 3.2 with the Chief Judge receiving 10% of such cases and the remaining six judges each receiving 15% of such cases. For these cases, the assigned Judge shall schedule all hearings and other proceedings, and such Judge shall retain exclusive control and responsibility for these cases as provided for in Georgia Uniform Superior Court Rule 3.3., except for emergency matters which will be handled by the specified Presiding Judge as provided below.

The Superior Court Judges designate their individual Judicial Administrative Assistant as their designated calendar clerk for purposes of the above scheduling tasks, nisi and/or notice execution(s), docket publication(s), etc.

The Clerk of Superior Court shall maintain the same process and protocol currently in place regarding all Family Violence / Protective Order matters, with the scheduling of same coinciding with the current Superior Court Judges' Schedule attached hereto. All applications seeking temporary protective orders, temporary restraining orders, and similar emergency civil and domestic relief shall be addressed and resolved on a temporary basis by the Presiding Judge as specified in such schedule. The specified Presiding Judge shall also consider and rule upon all search warrants and arrest warrants sought during business hours, with such warrants sought outside of business hours to be handled by Assistant Magistrates appointed for this purpose by separate order.

The Presiding Judge can only exercise jurisdiction in an actual case or controversy. Accordingly, any petitions or complaints for cases in which emergency relief is sought from the Presiding Judge must have previously been filed with and assigned a case number by the Clerk of Superior Court.

Pursuant to Georgia Uniform Superior Court Rule 8.4, the parties and counsel in the first 10 actions on a published civil/domestic trial calendar in this Circuit shall appear ready for trial on the date specified unless otherwise directed by the assigned Judge. Additionally, continuances will not be granted merely by agreement of counsel and actions will not be removed from a published trial calendar except by Court direction pursuant to Georgia Uniform Superior Court Rule 8.5.

Criminal matters in the Superior Court of Muscogee County shall be randomly assigned by the Clerk of said Court among all seven Judges as provided in Georgia Uniform Superior Court Rule 3.1 and 3.2 to the end that each Judge is allocated an equal number of cases.

Unless otherwise directed by the Court, the Clerk of Court shall schedule all hearings and other proceedings with respect to all criminal cases assigned to each Judge. All criminal dates available for scheduling are indicated by the current Superior Court Judges' Schedule attached hereto. The assigned Judge shall retain exclusive control and responsibility for these cases as provided in Georgia Uniform Superior Court Rule 3.3.

Pursuant to Georgia Uniform Superior Court Rule 32.2, no criminal case shall be postponed or removed from a trial calendar in this Circuit except by the direction of the Judge presiding over the case.

Notwithstanding any other provision of this Order, and unless otherwise ordered by the Court, petitions alleging violation of probation shall be filed and served within thirty (30) days of execution of any probation arrest warrant.

Parties and counsel shall strictly adhere to the conflict rules set forth at Georgia Uniform Superior Court Rule 17.1, including the provision of timely notice of the conflict(s) and a proposed resolution of the conflict(s) to the proper Court(s) and parties.

Members and representatives of the news media are reminded of the provisions set forth in Georgia Uniform Superior Court Rule 22 and shall take all steps required by such rule pertaining to written notice and service of requests thereunder.

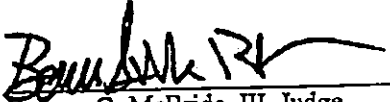
